Treasurer's report: General IMMA cash on hand as of 11/30/2021 was: \$33,585.98. December deposits were: \$33,600.17 and with a transfer to Checking of \$8,648.00; with a balance on hand as of 12/31/2021 of \$58,538.15.

General Fund Checking cash on hand as of 11/30/2021 was \$1.24. December interest was \$0.19. December deposits were \$8,659.19. December disbursements were \$8,648.31 for a balance on hand as 12/31/2021 of \$12.12.

Municipal Money Market worth as of 12/31/2021 was \$58,538.15. General Fund Checking worth was \$12.12, and Investments on Deposit as of 12/31/2021 was \$242,864.65 for a total net worth of \$301,414.92, which is \$92,868.84 more than the total worth this month last year.
