

**Grant Township Monthly Board Meeting

March 8, 2022

The Grant Township board meeting was called to order at 6:00pm by Trustee Boyd.

The pledge was recited by all.

Board members present: Trustee Eric Boyd, Trustee Shawna McManus, Clerk Toinelle Moulder and Treasurer Rachel Vallance. Absent: Supervisor Gil Archambo. Two general public members were in attendance.

Addition to agenda: Approve 2022-2023 yearly budget  
Motion to accept the agenda with additions: by Treasurer Vallance and supported by Trustee McManus. All approved, motion carried.

Motion for the approval of minutes from the February 8, 2022 meeting, by Treasurer Vallance and supported by Trustee McManus; All approved, motion carried.

Clerks Report: Clerk Moulder informed board that she would be resigning as of 3/31/22. The deputy clerk, Theresa Berden, will fill the role until appointment of someone by the board.

Clerk received the Cheboygan County Humane Society contract along with the 2021 animal control information. Grant Township had zero animal control services used in 2021. Check will be cut for \$1500 for the annual contract.

Treasurer's report: General IMMA cash on hand as of 1/31/22 was: \$63,691.70. February's deposits were: \$680.87 and with a transfer to Checking of \$10,539.00; with a balance on hand as of 2/28/2022 of \$53,833.57.

General Fund Checking cash on hand as of 1/31/22 was \$1.48. February interest was \$0.22. February deposits were \$10,539.22. February disbursements were \$10,539.87 for a balance on hand as 2/28/2022 of \$.83.

Municipal Money Market worth as of 2/28/2022 was \$53,833.57. General Fund Checking worth was \$.83, and Investments on Deposit as of 2/28/2022 was \$242,864.65 for a total net worth of \$296,699.05, which is \$63,748.53 more than the total worth this month last year.

Motion to approve the Treasurers report, by Clerk Moulder and supported by Trustee McManus, All approved, motion carried.

Old Business: Fire Department—interlocal department agreement—township still waiting to receive from Lawyer MacArthur—tabled until April meeting.

New Business: Held budget meeting prior to monthly board meeting. The board did a roll call vote to approve the 2022-2023 budget as presented.

Resolutions were presented, That the Salaries of the Board be increased:

Supervisor \$12,444 per year

Clerk \$15,504 per year

Tres. \$11,172 per year plus SET @ \$2.00 a parcel

Trustees \$2,506 per year

All Board Members be paid per diem of \$80 for meetings outside of the Township. Board of Review at \$168.00 per day and ½ day at \$84.00. Library Board to be paid \$80.00 per month. Salary resolutions for the board members and employees of the township, as well as Board of Review and election workers were approved by roll call vote.

Motion to approve the budget and resolutions was made by Treasurer Vallance and supported by Trustee Boyd. This was approved by a roll call vote: Boyd: yes, Moulder: yes, McManus: yes, Vallance: yes, Archambo: absent

Meeting Reports: Trustee Boyd reported on Oakhill Cemetery and the Planning Commission.

Website/Newsletter- Clerk Moulder informed the board that there has been issues with uploading information to the website, and that they are looking into companies to get build a new website. The cost of a new website was built into the 2022-2023 budget.
