Treasurer's report: General IMMA cash on hand as of 10/31/2021 was: \$49,306.75. November deposits were: \$15,856.40 and with a transfer to Checking of \$31,577.17; with a balance on hand as of 11/30/2021 of \$33,585.98.

General Fund Checking cash on hand as of 10/31/2021 was \$1.18. November interest was \$0.28. November deposits were \$10,074.28. November disbursements were \$10,074.22 for a balance on hand as 1/30/2021 of \$1.24.

Municipal Money Market worth as of 11/30/2021 was \$33,585.98. General Fund Checking worth was \$1.24, and Investments on Deposit as of 11/30/2021 was \$242,809.50 for a total net worth of \$276,396.72, which is \$54,387.44 more than the total worth this month last year.
