Treasurer's report: General IMMA cash on hand as of 5/31/2021 was: \$12,3824.19. June deposits were: \$6,313.74 and with a transfer to Checking of \$23,977.00; with a balance on hand as of 6/30/2021 of \$106,160.93.

General Fund Checking cash on hand as of 5/31/2021 was \$388.21. June interest was \$0.51. June deposits were \$23,977.51. June disbursements were \$24,364.95 for a balance on hand as of 6/30/2021 of \$0.77.

Municipal Money Market worth as of 6/30/2021 was \$106,160.93. General Fund Checking worth was \$0.77, and Investments on Deposit as of 5/31/2021 was \$168,105.99 for a total net worth of \$274,267.69, which is \$10,145.38 more than the total worth this month last year.

It went up three years ago and someone bought it but it's land locked and I don't think they were able to get access to it so they let it go back. Parcel number 151-020-400-002-00. Board approved, and right of refusal signed.
