Treasurer's report: General IMMA cash on hand as of 09/30/2021 was: \$80,430.16. October deposits were: \$64.22 and with a transfer to Checking of \$31,187.63; with a balance on hand as of 10/31/2021 of \$49,306.75.

General Fund Checking cash on hand as of 9/30/2021 was \$1.19. October interest was \$0.20. October deposits were \$21,050.58. October disbursements were \$21,050.59 for a balance on hand as 10/31/2021 of \$1.18.

Municipal Money Market worth as of 10/31/2021 was \$49,306.75. General Fund Checking worth was \$1.18, and Investments on Deposit as of 10/31/2021 was \$178,437.52 for a total net worth of \$227,745.45, which is \$9,265.04 more than the total worth this month last year.

Treasurer Vallance cashed in on mature certificate, withdrew money to create a new certificate to yield higher percentage of interest.
