July 12, 2022

The Grant Township board meeting was called to order at 6:00pm by Supervisor Archambo.

The pledge was recited by all.

Board members present: Supervisor Gil Archambo, Trustee Eric Boyd, Trustee Shawna McManus, Treasurer Rachel Vallance, and Clerk Theresa Berden. With 3 residents present.

Addition to agenda: None

Motion to accept the agenda with additions: by Treasurer Vallance and supported by Trustee Boyd. All approved, motion carried.

Motion for the approval of minutes from the June 14th, 2022 meeting, by Treasurer Vallance and supported by Trustee McManus. All approved, motion carried.

Clerks Report: Election Inspectors appointed at commission meeting on July 12th; Public Accuracy test will be held July 21st at the hall; MTA dues have been paid, including training for board members.

Treasurer's report: General IMMA cash on hand as of 5/31/22 was: \$106,038.54. June deposits were: \$3,820.41 and with a transfer to Checking of \$54,776.00; with a balance on hand as of 6/30/2022 of \$55,082.95.

General Fund Checking cash on hand as of 5/31/22 was \$.87. June interest was \$1.52. June deposits were \$54,777.52. June disbursements were \$54,776.71 for a balance on hand as 6/30/2022 of \$.1.68.

Municipal Money Market worth as of 5/31/2022 was \$55,082.95. General Fund Checking worth was \$1.68, and Investments on Deposit was \$243,133.93 for a total net worth of \$298,218.56, which is \$29,950.87 more than the total worth this month last year.

Motion to approve the Treasurers report, by Trustee Boyd and supported by Trustee McManus. All approved, motion carried.

Public Speakers: Roberta Matelski spoke regarding the County Commissioners meeting.

Public Comment: Resident expressed concern about potentially being reported for blight; wanted to inform board that she is doing what she can do deal with a falling down cabin, but there is asbestos and she is not having luck finding affordable abatement services. Board thanked her for coming and provided her with numbers for the County Building where she may be able to find help.

New Business: Two blight complaints that were going to be brought to the board were not, one of which was taken care of through the county.
