Treasurer's report: General IMMA cash on hand as of 6/30/22 was: \$55,082.95. July deposits were: \$57,286.81 and with a transfer to Checking of \$22,792.00; with a balance on hand as of 7/31/2022 of \$89,577.76.

General Fund Checking cash on hand as of 6/3022 was \$1.68. July interest was \$.50. July deposits were \$22,992.50. July disbursements were \$22,992.91 for a balance on hand as 7/31/2022 of \$1.27.

Municipal Money Market worth as of 7/31/2022 was \$89,577.76. General Fund Checking worth was \$1.27, and Investments on Deposit was \$243,133.93 for a total net worth of \$332,712.96, which is \$79,996.45 more than the total worth this month last year.

Motion to approve the Treasurers report, by Trustee Boyd and supported by Trustee McManus. All approved, motion carried.

Public Speakers: Roberta Matelski spoke regarding the County Commissioners meeting. Judge Aaron Gauthier spoke gave an update on his court, including Recovery Court and court being back in person, though video feed is still available.

Public Comment: Resident submitted a blight complaint from herself and neighbors regarding a home on Black Lake that was not being maintained; board accepted the complaint and agreed to observe the property prior to the next meeting.

New Business: A resolution regarding providing PIE&G right of way access for broadband service was reviewed by the board. A motion was made by Trustee Boyd to approve the resolution with support by Treasurer Vallance. Roll call: Archambo: yes; Berden: yes; Boyd: yes; McManus: yes; Vallance: yes. All approved, motion carried.

Supervisor Archambo provided a written copy of a blight complaint made by a resident regarding a burnt structure on Trudeau Road; the board accepted it and agreed to observe the property prior to the next meeting.

Clerk Berden will add a Blight section to the agenda moving forward.
