

Grant Township Monthly Board Meeting

October 11, 2022

The Grant Township board meeting was called to order at 6:00pm by Supervisor Archambo.

The pledge was recited by all.

Board members present: Supervisor Gil Archambo, Trustee Eric Boyd, Trustee Shawna McManus, Treasurer Rachel Vallance, and Clerk Theresa Berden. With no residents present.

Addition to agenda: None

Motion to accept the agenda with additions: by Treasurer Vallance and supported by Trustee Boyd. All approved, motion carried.

Motion for the approval of minutes from the September 13th, 2022 meeting, by Treasurer Vallance and supported by Trustee McManus. All approved, motion carried.

Clerks Report: Election Commission appointed inspectors at meeting prior to board meeting; audit was completed by Nieland and Kosanke, with binders provided to board; reminder that November meeting is on November 7th due to the election being on the second Tuesday.

Treasurer's report: General IMMA cash on hand as of 8/31/22 was: \$81,261.40. September deposits were: \$15,587.01 and with a transfer to Checking of \$9,379.00; with a balance on hand as of 9/30/2022 of \$87,469.41.

General Fund Checking cash on hand as of 8/31/2022 was \$.45. September interest was \$.09. September deposits were \$9,379.00. September disbursements were \$9,378.44 for a balance on hand as 9/30/2022 of \$1.10.

Municipal Money Market worth as of 8/31/2022 was \$87,469.41. General Fund Checking worth was \$1.10, and Investments on Deposit was \$243,312.41 for a total net worth of \$330,782.92, which is \$82,119.20 more than the total worth this month last year including ARPA funds.

Motion to approve the Treasurers report, by Trustee Boyd and supported by Trustee McManus. All approved, motion carried.

Old Business: Treasurer Vallance updated the board that she continued to work on issues arisen with the IRS regarding correct information from 2018. Currently, we have until 11/7/22 to have it resolved.

New Business: Cheboygan County provided an update to the recycling agreement. Clerk will sign for an extension given board approval. Motion was made by Treasurer Vallance to extend the agreement; support given by Trustee Boyd. All approved, motion carried.

Blight: No new blight complaints. Supervisor Archambo shared an update from Complaint #2 that the yard had been picked up and mowed despite the Sheriff's office declining to move forward with the complaint.

Meeting Reports: Trustee Boyd reported on the Planning Commission meeting and local MTA meeting.

Trustee McManus reported on the DNR informational meeting regarding the marina/boat launch on Viau Rd.

Supervisor Archambo gave update on insurance walk-through including the desire to have an AED training for board staff; Matt Barber Masonry and Construction is scheduling to get roof repaired.

Website/Newsletter- Treasurer is putting the newsletter together before next board meeting.

Motion to pay bills made by Treasurer Vallance, with support from Trustee Boyd. Motion approved by a roll call vote: Boyd: yes, McManus: yes, Vallance: yes, Archambo: yes, Berden: yes.

Motion by Treasurer Vallance to adjourn the meeting; supported by Trustee Boyd. All approved, motion carried.
