The Grant Township board meeting was called to order at 6:00pm by Supervisor Archambo.

The pledge was recited by all.

Board members present: Supervisor Gil Archambo, Trustee Eric Boyd, Trustee Shawna McManus, Treasurer Rachel Vallance, and Clerk Theresa Berden. With 5 residents present.

Addition to agenda: None

Motion to accept the agenda with no additions: by Trustee Boyd and supported by Trustee McManus. All approved, motion carried.

Motion for the approval of minutes from the October 11, 2022 meeting, by Treasurer Vallance and supported by Trustee Boyd. All approved, motion carried.

Clerks Report: Election on 11/8; capital fund rebate from PIE&G; clerk provided publications for review.

Treasurer's report: Treasurer's report: General IMMA cash on hand as of 9/30/22 was: \$87,469.41. October deposits were: \$0.00 and with a transfer to Checking of \$19,271.00 with a balance on hand as of 10/31/2022 \$68,204.80.

General Fund Checking cash on hand as of 9/30/2022 was \$1.10. October interest was \$.31. October deposits were \$19,271.00. October disbursements were \$19,270.32 for a balance on hand as of 10/31/22 of \$2.09.

Municipal Money Market worth as of 9/30/2022 was \$68,204.80. **General Fund Checking worth was \$2.09, and Investments on Deposit as was \$243,177.73** for a total net worth of \$311,384.62 which is \$83,639.17 more than the total worth this month last year.

Motion to approve the Treasurers report, by Trustee Boyd and supported by Trustee McManus. All approved, motion carried.

Old Business: Treasurer Vallance updated board on IRS progress. It is moving forward well, though the treasurer has put a lot of time into the inquiry and is waiting on additional paperwork from the IRS.

Blight: New blight complaint presented to board regarding a home on Page Rd. Board will send complaint to sheriff's office due to knowing the property well. Supervisor Archambo will look into the last blight complaint to see the progress.

Public Comment: Resident in attendance asked about an update on the solar farm. Supervisor Archambo stated that a new permit was granted which gave the company an extension, but no further update was known. Resident stated that they were informed that the earliest anything would start would be 2023.

Meeting Reports: Trustee Boyd reported on the Planning Commission meeting and local MTA meeting.

Website/Newsletter- Board agreed the newsletter looked good; Treasurer Vallance to send to the publisher.

Motion to pay bills made by Treasurer Vallance, with support from Trustee McManus. Motion approved by a roll call vote: Boyd: yes, McManus: yes, Vallance: yes, Archambo: yes, Berden: yes.

Motion by Trustee Boyd to adjourn the meeting; supported by Treasurer Vallance. All approved, motion carried.
