

**Grant Township Monthly Board Meeting**

The Grant Township board meeting was called to order at 6:00pm by Supervisor Archambo.

The pledge was recited by all.

Board members present: Supervisor Gil Archambo, Trustee Eric Boyd, Trustee Shawna McManus, Treasurer Rachel Vallance, and Clerk Theresa Berden. With 4 residents present.

Addition to agenda: None

Motion to accept the agenda with no additions: by Treasurer Vallance and supported by Trustee Boyd. All approved, motion carried.

Motion for the approval of minutes from the November 7, 2022 meeting, by Trustee Boyd and supported by Treasurer Vallance. All approved, motion carried.

Clerks Report: Genealogical Society asking for help; state forfeiture report due; sending hall use agreement to associations (all board in favor).

Treasurer's report: Treasurer's report: General IMMA cash on hand as of 10/31/22 was: \$68,204.80. November deposits were: \$16,330.96 and with a transfer to Checking of \$30,707.00 with a balance on hand as of 11/30/2022 \$53,828.76.

General Fund Checking cash on hand as of 10/31/2022 was \$2.09. November interest was \$.89. November deposits were \$30,707.89. November disbursements were \$30,708.14 for a balance on hand as of 11/30/22 of \$1.84.

Municipal Money Market worth as of 11/30/2022 was \$53,828.76. **General Fund Checking worth was \$1.84, and Investments on Deposit as was \$243,177.73** for a total net worth of \$297,008.33 which is \$20,611.61 more than the total worth this month last year.

Motion to approve the Treasurers report, by Trustee Boyd and supported by Trustee McManus. All approved, motion carried.

Old Business: Treasurer Vallance updated board on IRS progress. Treasurer Vallance is as far as she can go with the inquiry and is waiting on additional paperwork from the IRS.

New Business: Clerk Berden presented the bid for dumpster days in 2023, though they are incorrect with one of the days and the times. A motion to sign and return the bid with corrected dates and times was made by Treasurer Vallance; supported by Trustee McManus. All approved, motion carried

Blight: Residents informed the board they would like to file a complaint regarding a residence on Page Rd. It was explained that the residence had already received a complaint and was working through the blight process through the Sheriff's Office and had been served notice. It was explained that additional complaints would not result in additional notices. Residents stated that they did not wish to file a complaint form if the home was already turned over to the Sheriff. Supervisor Archambo stated that he would try to have an update at the next meeting.
