The Grant Township board meeting was called to order at 6:00pm by Trustee Boyd.

Treasurer's report: Treasurer's report: General IMMA cash on hand as of 11/30/22 was: \$53,828.76. December deposits were: \$34,278.29 and with a transfer to Checking of \$13,108.00 with a balance on hand as of 12/31/2022 \$74,999.05.

General Fund Checking cash on hand as of 11/30/2022 was \$1.84. December interest was \$.15. December deposits were \$13,108.15. December disbursements were \$13,109.26 for a balance on hand as of 12/31/22 of \$.73.

Municipal Money Market worth as of 12/31/2022 was \$74,999.05. **General Fund Checking worth was \$.73, and Investments on Deposit as was \$243,533.81** for a total net worth of \$318,533.59 which is \$17,118.67 more than the total worth this month last year.

Motion to approve the Treasurers report by Trustee McManus and supported by Trustee Boyd. All approved, motion carried.

Old Business: Treasurer Vallance updated board on IRS progress. All documentation has been sent to the IRS and Treasurer is waiting for updated information.

New Business: Board discussed use of ARPA funds for updating the registers and getting air conditioning through Werners. A bid for updating the bathrooms to be ADA complaint is being done.

Clerk Berden presented the Poverty Exemption Guidelines for 2023. A motion was made by Treasurer Vallance to adopt the 2023 guidelines as presented, which was supported by Trustee Boyd. All approved, motion carried.
