The Grant Township board meeting was called to order at 6:00pm by Supervisor Archambo.

The pledge was recited by all.

Board members present: Supervisor Archambo, Trustee Shawna McManus, Treasurer Rachel Vallance, Trustee Eric Boyd, and Clerk Theresa Berden. With 1 resident present.

Addition to agenda: Add discussion of fire extinguishers under old business.

Motion to accept the agenda with additions: by Treasurer Vallance and supported by Trustee McManus. All approved, motion carried.

Motion for the approval of minutes from the October 10, 2023 meeting, by Trustee Boyd and supported by Treasurer Vallance. All approved, motion carried.

Clerks Report: Updated dumpster times for 2024 contract; clerk ordered ballot box, will need it installed in entry way; need to order camera; Clerk to do audit for AF Insurance for workman's compensation insurance; completed survey through LARA regarding broadband

Treasurer's report: General IMMA cash on hand as of 9/30/23 was: \$64,668.59. October deposits were: \$101,618.24 and with a transfer to Checking of \$80,179.00 with a balance on hand as of 10/31/2023 \$86,107.83

General Fund Checking cash on hand as of 9/30/2023 was \$1.42. October interest was \$1.63. October deposits were \$80,180.63. October disbursements were \$80,123.61 for a balance on hand as of 10/31/23 of \$58.44.

Municipal Money Market worth as of 10/31/2023 was \$86,107.83. General Fund Checking worth was \$58.44, and Investments on Deposit as was \$144,042.51 for a total net worth of \$230,208.78 which is \$81,175.84 less than the total worth this month last year.

Treasurer Vallance informed board of the transfer of funds from a matured CD.

Motion to approve the Treasurer's report by Trustee Boyd and supported by Trustee McManus. All approved, motion carried.

Old Business: Tax update—Treasurer Vallance advised nothing new has happened. The IRS is still working on what was submitted.

Fire Extinguishers—Trustee Boyd attempted to contact the company to check extinguishers at the hall and has not heard back. He will continue and if he is not able to make contact, will inform Treasurer Vallance so that it can be brought up at the Fire Department meeting.

New Business: Retirement—Clerk Berden phoned retirement broker during the meeting. Kevin Mannor explained issues that they have had with Brighthouse and answered questions about possibly switching retirement to another company.

Blight: No new complaints. Supervisor Archambo will follow up on Page Rd complaint.
