The Grant Township board meeting was called to order at 6:00pm by Supervisor Archambo.

Pledge of Allegiance recited.

Treasurer's report: General IMMA cash on hand as of 5/31/24 was: \$134,323.03. June deposits were: \$9,094.61 with a transfer to Checking of \$49,627.00 with a balance on hand as of 6/30/2024 of \$93,790.64.

General Fund Checking cash on hand as of 5/31/24 was \$1.45. June interest was \$1.17. June deposits were \$49,639.17. June disbursements were \$49,638.05 for a balance on hand as of 6/30/24 of \$2.57.

Municipal Money Market worth as of 6/30/24 was \$93,790.64. **General Fund Checking worth was \$2.57, and Investments on Deposit as was \$164,080.38** for a total net worth of \$257,873.59 which is \$40,966.42 less than the total worth this month last year.

Motion to approve the Treasurer's report by Trustee Boyd and supported by Trustee McManus. All approved, motion carried.
